

# Dark Horse Saddlery

## Saddle Trial/Loan Agreement

Please read the following document carefully before initialing and signing.

This agreement may be amended by Dark Horse Saddlery as necessary. In cases where an amendment is to be made the client will be notified before hand.

Terms and conditions of loan.

\_\_\_\_\_The saddle must be returned in the same condition it left Dark Horse Saddlery. Any damage or excessive wear to the saddle will be charged to the client. Saddles are loaned without accessories. If girth and stirrup leathers are required, this must be arranged separately. Stirrup leathers will be attached under the flap to not create any rub marks on the flap.

\_\_\_\_\_The client is responsible for collection and return of the saddle at their expense. (In case of shipping the saddle by Canada Post Expedited Parcel, Dark Horse Saddlery will arrange for the outward shipping at the client's expense and may specify how the saddle is to be returned.) Saddles must be insured for the full purchase price during shipping.

\_\_\_\_\_If the saddle is being collected / returned by hand, then arrangements must be made with Dark Horse Saddlery in advance.

\_\_\_\_\_The saddle must be returned to arrive back at Dark Horse Saddlery 8 days after the client receives the saddle,( Canada Post notifies DHS at the time of deliver of the saddle). Failure to do so will result in the client being charged the full purchase price of the saddle and the saddle will then become the property of the client.

\_\_\_\_\_The saddle will only be used for the horse and rider specified on the agreement. It shall not be otherwise loaned or hired to any other party. The client agrees to take full responsibility for the saddle until it is returned to Dark Horse Saddlery.

\_\_\_\_\_Saddles are not to be left at barns or in unlocked tack rooms. They are not to be left sitting on the floor or stable doors. When a cover is (provided) should be kept on the saddle when not in use. Not all models come with covers. The saddle should not be cleaned with anything other than a damp cloth and an agreed leather cleaner and should **NOT** be oiled. A cleaning fee of \$45.00 will be charged if the saddle is returned in other then the same condition sent out.

\_\_\_\_\_The client agrees to send a cheque, which will be cashed, for the full purchase price or give credit card details of a valid credit card with enough credit to cover the purchase price of the saddle. This will be charged on pickup and on the return of the saddle the appropriate amount will be refunded to the client.

\_\_\_\_\_ US clients are required to return the saddle with the Return Merchandise form included on the outside of the box and clearly marked for Border Customs agents. **Declared value must be \$1000 as not to incur Duty charges on the return across the border. Failing to follow these conditions, resulting in customs duty charges will be billed directly to the client.**

\_\_\_\_\_ **Clients bringing in saddles from DP Saddlery's warehouse for Trial will charged shipping from the warehouse to the clients location. Return shipping charges will be charged to return the saddle to the warehouse.** I strongly advise in ordering a saddle for trial that picking the best possible match be considered to avoid unnecessary shipping costs.

Agreement between client and Dark Horse Saddlery.

I agree to the terms set out above and accept all liability for the saddle and its' use from the time it is collected to the time it is returned. I accept that Dark Horse Saddlery takes no liability for any damage that may occur to horse, rider or any third party due to the use of this saddle.
